

## 2010 ACT Summer Camp: Financial Assistance Form

Financial Assistance is available for ACT classes and camps on the basis of family need. Applications will be reviewed on a first-come, first-served basis and are approved according to availability of camp space and financial assistance funds. Applications for Summer Camp 2010 must be received by April 30<sup>th</sup>, 2010 to be considered. This year scholarship funds are very limited. As such, we ask every family to pay as much towards the tuition as they can afford so that we may spread the scholarship money to as many families as possible.

1. Applications will only be accepted with complete information. All questions MUST be answered, all spaces MUST be filled.
2. Only one Financial Assistance request may be submitted per camper.
3. Applications must be submitted with the appropriate 2010 Camp Registration Form
4. Camper may not receive the entire requested amount. Janna Hoekema, Camp Director at Asheville Community Theatre or another ACT staff member will contact you to discuss the amount of financial assistance you have been awarded and your balance due before the end of May, 2010.
5. Applications will be reviewed and processed on a point scale to maintain fairness to everyone. The points will be based on 1. camp program expense, 2. family size, 3. income range, 4. financial contributions and 5. funding in the past.
